**RULES RELATING TO CHANGE OF SUBJECTS**

1. Regular college students are not allowed to change their subjects.
2. Private candidates can change their subject(s) within the allowed combination but not more than two subjects at a time.
3. Late college students are allowed to change their subjects from amongst the allowed combinations on a condition that they will no longer be considered as late college student(s) and will be treated as a Private Candidate.
4. If a candidate appears with a changed subject not originally offered in the Examination Admission Form his/her paper(s) shall be considered as cancel.

**NOTE:** Candidate will be required to apply for change of subjects two months before the commencement of the prescribed Examination. They will have to pay Rs. 1000/- per paper. The fee will be permitted in the name of Treasurer, Kohat University of Science and Technology, Kohat.
